A new feature, "*Constitutionally Speaking*" has been added to the newsletter, thanks to Secretary Jeff Kovite.

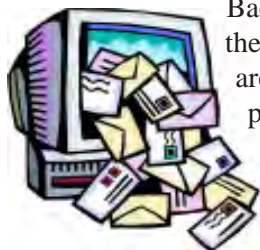

Perhaps Gil would share with me so I no longer have to beg! - Sandie



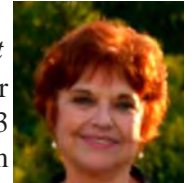

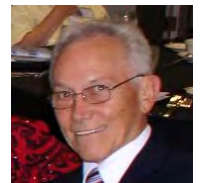

# The Treasurer's Report

As an Officer of any organization, the Treasurer is charged with providing management with the necessary information to well govern that organization. To accomplish those goals, the Treasurer must first determine the answers that he and management will need.

To that end, the rule is that "Form Follows Function" whereby the documents created will provide the information for both current use and for historical purposes.

It is not only important to know where you want to go, but where you have been and what you have learned in those travels. These lessons probably apply to many more things than just tracking the numbers.

The second step in all of this is the next rule: "KISS" (*Keep It Simple Stupid*). If the Treasurer makes it too complicated then neither he nor management will be able to understand it or be able to use the information. Hopefully, I have attained those goals in the management of "your" funds, as they belong to all shipmates.

Each month, a report of the activities is sent to all Officers, Board Members and interested shipmates.



request a copy of that report at any time, just send the Treasurer an email address and it will be sent out to you.

The report shows each month in the current fiscal year and how we are progressing through the year. ANY shipmate may request a copy of that report at

One example of the many "Form Follows Function" documents created for the Association is the Reservation Form for the Reunion in Annapolis in August 2017. The information provided there gives the Reunion Committee the necessary dinner counts, who is going on tours, information for ID badges, etc. and a reconciliation of the funds charged and received to conduct the Reunion.



Keep in mind that the Reservation Form was prepared *ten months in advance of the Reunion*, so you can see how important it is to get the right answers.

Once each individual response is transferred to the Master List of Reservations, the original reservation forms are kept as the backup for any questions that may arise.

Finally, a continued request for all shipmates that are able to send in their dues payment. Dues are the primary source of income for the Association to pay the necessary bills.

Keep in mind that your Association is staffed by "volunteer" shipmates who receive NO compensation for their efforts. The only expenses incurred are those that provide goods and services to all shipmates.

That is all for this report – May you have fair winds and following seas in all that you do.

## Excerpts from the Inaugural Address of 1933

"This is pre-eminently the time to speak the truth, the whole truth, frankly and boldly. Nor need we shrink from honestly facing conditions in our country today.

This great nation will endure as it has endured, will revive and will prosper. So first of all let me assert my firm belief that the only thing we have to fear is fear itself - nameless, unreasoning, unjustified terror which

paralyzes needed efforts to convert retreat into advance. In every dark hour of our national life a leadership of frankness and vigor has met with that understanding and support of the people themselves which is essential to victory. I am convinced that you will again give that support to leadership in these critical days. In such a spirit on my part and on yours we face our common difficulties."

## Constitutionally Speaking...

Shipmates,

In the November issue, I spoke about the first ten amendments to the Constitution, i.e., the Bill of Rights, that are incorporated within. In the same article, the Oath of Office for the President of the United States was included.

To continue, I have outlined the requirements and responsibilities of the President in the box to the right as they pertain to the Constitution.

Our Constitution is a "Living Document" As such, our forefathers, in their wisdom, took a pragmatic and measured approach during its creation.

In future newsletters, we will continue to highlight other Articles that make this document a beacon to the world, and one that lives and breathes democracy. - Jeff

### A Special Report by Secretary Kovite

1. Article II states the President is the chief executive, holds the office for four years and is directly elected by the Electors, one for each Senator and member of the House of Representatives.
2. The President must be a natural born citizen, at least 35 years of age and a resident of the United States for 14 years.
3. He is Commander-in-Chief of the armed forces and state militias and, with the Advice and Consent of the Senate, can make treaties, nominate and appoint ambassadors, judges and other federal officers, including military.
4. He shall from time to time give to the Congress information on the State of the Union (it doesn't say how-he can send a letter if he likes.)
5. He shall take Care that the Laws be faithfully executed.
6. He can be removed from office upon conviction for Treason, Bribery, or other high Crimes and Misdemeanors.
